

Contract Agreement Form for Supply and Delivery of Nutri-packs for the 10th Cycle Implementation of the Supplementary Feeding Program during Community Quarantine, Oriental Mindoro – Lot 1

CONTRACT AGREEMENT

THIS AGREEMENT made this 21st day of June 2021 between **Department of Social Welfare and Development MIMAROPA Region** located at 1680 F. T Benitez cor Malvar Sts., Malate, Manila, Philippines represented by **Regional Director FERNANDO R. DE VILLA JR., CESO III** (hereinafter called "the Entity") of the one part and **PHILIPPINE NUTRI-FOODS CORPORATION** represented by **PAUL R. HIPOLITO** located 605 COHERCO Financial Tower Trade St., Cor. Investment Drive Alabang, Muntinlupa City, Metro Manila (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for Supply and Delivery of Nutri-packs for the 10th Cycle Implementation of the Supplementary Feeding Program during Community Quarantine, Oriental Mindoro – Lot 1 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Three Million Seven Hundred Twenty-Nine Thousand Six Hundred Pesos Only (Php3,729,600.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
