

Contract Agreement Form for Supply and Delivery of Various Food Items for the 10th Cycle Implementation of the Supplementary Feeding Program in Mansalay, Oriental Mindoro – Lot 6 with Project ID No. DSWD4B-2021-010

CONTRACT AGREEMENT

THIS AGREEMENT made this 15th day of July 2021 between **Department of Social Welfare and Development MIMAROPA Region** located at 1680 F. T Benitez cor Malvar Sts., Malate, Manila, Philippines represented by **Regional Director FERNANDO R. DE VILLA JR., CESO III** (hereinafter called “the **Entity**”) of the one part and **ARTAMAS 77 CONSUMER GOODS TRADING** represented by **ARNOLD R. SAMATRA** located Marfrancisco, Pinamalayan, Oriental Mindoro (hereinafter called “the **Supplier**”) of the other part;

WHEREAS, the Entity invited Bids for Supply and Delivery of Various Food Items for the 10th Cycle Implementation of the Supplementary Feeding Program in Mansalay, Oriental Mindoro – Lot 6 with Project ID No. DSWD4B-2021-010 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Five Hundred Sixty-Two Thousand Nine Hundred Sixty Pesos and 06/100 (Php1,562,960.06)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

In consideration for the sum of **One Million Five Hundred Sixty-Two Thousand Nine Hundred Sixty Pesos and 06/100 (Php1,562,960.06)** or such other sums as may be ascertained, **ARTAMAS 77 CONSUMER GOODS TRADING**, agrees to perform Supply and Delivery of Various Food Items for the 10th Cycle Implementation of the Supplementary Feeding Program in Mansalay, Oriental Mindoro – Lot 6 with Project ID No. DSWD4B-2021-010 in accordance with its Bid.
- 4. The *DSWD MIMAROPA Region* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
