

Contract Agreement Form for Supply and Delivery of Various Food Items and Commodities for the 11th Cycle Implementation of Supplementary Feeding Program in Occidental Mindoro Lot 1; 2, 5, -11 with Project ID No. DSWD4B-2021-006

CONTRACT AGREEMENT

THIS AGREEMENT made this 16th day of July 2021 between **Department of Social Welfare and Development MIMAROPA Region** located at 1680 F. T Benitez cor Malvar Sts., Malate, Manila, Philippines represented by **Regional Director FERNANDO R. DE VILLA JR.,CESO III** (hereinafter called "the **Entity**") of the one part and **LUMAD SA ADGAWAN FARMERS MULTI-PURPOSE COOPERATIVE** represented by **MUARIEF LABAY MINANDANG** located Purok 3, Poblacion, La Paz, Agusan Del Sur, Caraga (hereinafter called "the **Supplier**") of the other part;

WHEREAS, the Entity invited Bids for Supply and Delivery of Various Food Items and Commodities for the 11th Cycle Implementation of Supplementary Feeding Program in Occidental Mindoro Lot 1; 2, 5, -11 with Project ID No. DSWD4B-2021-006 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Twenty-Five Million Nine Hundred Forty-Two Thousand Fifty-Four Pesos and 87/100 only (Php25,942,054.87)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

In consideration for the sum of **Twenty-Five Million Nine Hundred Forty-Two Thousand Fifty-Four Pesos and 87/100 only (Php25,942,054.87)** or such other sums as may be ascertained, **LUMAD SA ADGAWAN FARMERS MULTI-PURPOSE COOPERATIVE**, agrees to *perform* Supply and Delivery of Various Food Items and Commodities for the 11th Cycle Implementation of Supplementary Feeding Program in Occidental Mindoro Lot 1; 2, 5, -11 with Project ID No. DSWD4B-2021-006 *in accordance with its Bid.*
- 4. The *DSWD MIMAROPA Region* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
