



SIMULATION OF BIRTH

Tumutukoy sa pandaraya sa Sertipiko ng Kapanganakan upang palabasin na ang isang bata ay ipinanganak ng isang babae, subalit hindi siya ang tunay na ina ng bata.

Sa ilalim ng revised penal code, ito ay itinuturing na eriminal offense (Art. 347). Ngunit, sa panibagong batas na RA 11222, maaring ma-exempt mula sa pagkakasala ang mga nag-simulate ng birth certificate.

SIMULATED BIRTH RECTIFICATION ACT

Ang Republic Act No. 11222 o ang Simulated Birth Rectification Act ay ang batas na nagbibigay ng amnestiya sa mga Pilipinong nag-simulate o pumake sa Birth Certificate ng isang bata na hindi niya tunay na anak. Layunin nitong bigyan ng pagkakataon ang mga kumupkop o nag-ampon na hindi dumaan sa tamang proseso na itama at gawing ligal ang pag-aampon.
