## Contract Agreement Form for Construction of One-Storey Isolation Building at MIMAROPA Youth Center

## CONTRACT AGREEMENT

THIS AGREEMENT made this 13th day of August 2021 between Department of Social Welfare and Development MIMAROPA Region located at 1680 F. T Benitez cor Malvar Sts., Malate, Manila, Philippines represented by Regional Director FERNANDO R. DE VILLA JR., CESO III (hereinafter called "the Entity") of the one part and SKYSCRAPER CONSTRUCTION AND ENGINEERING SERVICES represented by ENGR. JEMMAR S. SAPORNA, located at Brgy. 1 Buenavista, Marinduque (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Construction of One-Storey Isolation Building at MIMAROPA Youth Center and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Million Sixty Four Thousand Nine Hundred Twenty Pesos and 54/100 only (Php 1,064,920.54) (hereinafter called "the Contract Price").

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- In consideration for the sum of One Million Sixty-Four Thousand Nine Hundred Twenty Pesos and 54/100 Only (Php 1,064,920.54) or such other sums as may be ascertained, Skyscraper Construction and Engineering Services., agrees to perform the Construction of One-Storey Isolation Building at MIMAROPA Youth Center in accordance with its Bid.
- 4. The DSWD MIMAROPA Region agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
