

Contract Agreement Form for Supply and Delivery of Nutri-packs for the 10th Cycle Implementation of the Supplementary Feeding Program during Community Quarantine, Palawan – Lot 2

CONTRACT AGREEMENT

THIS AGREEMENT made this 16th day of July 2021 between **Department of Social Welfare and Development MIMAROPA Region** located at 1680 F. T Benitez cor Malvar Sts., Malate, Manila, Philippines represented by **Regional Director FERNANDO R. DE VILLA JR., CESO III** (hereinafter called "the **Entity**") of the one part and **PHILIPPINE NUTRI-FOODS CORPORATION** represented by **PAUL R. HIPOLITO** located 605 COHERCO Financial Tower Trade St., Cor. Investment Drive Alabang, Muntinlupa City, Metro Manila (hereinafter called "the **Supplier**") of the other part;

WHEREAS, the Entity invited Bids for Supply and Delivery of Nutri-packs for the 10th Cycle Implementation of the Supplementary Feeding Program during Community Quarantine, Palawan – Lot 2 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Four Million Eight Hundred Sixty-Three Thousand Six Hundred Pesos only (Php4,863,600.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

- i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and



- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
- 3. In consideration for the sum of **Four Million Eight Hundred Sixty-Three Thousand Six Hundred Pesos only (Php4,863,600.00)** or such other sums as may be ascertained, PHILIPPINE NUTRI-FOODS CORPORATION, agrees to *perform* Supply and Delivery of Nutri-packs for the 10th Cycle Implementation of the Supplementary Feeding Program during Community Quarantine, Palawan – Lot 2 *in* accordance with its Bid.
- 4. The *DSWD MIMAROPA Region* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
