CONTRACT AGREEMENT

THIS AGREEMENT made this the day of August 2022 between Department of Social Welfare and Development MIMAROPA Region located at 1680 F. T Benitez cor Malvar Sts., Malate, Manila, Philippines represented by Regional Director LEONARDO C. REYNOSO, CESO III (hereinafter called "the Entity") of the one part and NATIONAL COOPERATIVE MARKETING FEDERATION represented by ELICERIO P. - The DSWD MIMAROPA Region agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
