BAC RESOLUTION RECOMMENDING NEGOTIATED PROCUREMENT-SMALL VALUE PROCUREMENT AS MODE OF PROCUREMENT AND RECOMMENDING AWARD

WHEREAS, the Bids and Awards Committee through its Secretariat received an approved Purchase Request for the Consulting Services for the Structural Stability Assessment of DSWD MIMAROPA Regional Office;

WHEREAS, the approved Budget for the Contract for the said procurement activity is Three Hundred Thousand Pesos (Php 300,000.00):

WHEREAS, the abovementioned request is supplemented in the Annual Procurement Plan for CY 2022;

WHEREAS, following the procurement modality, Negotiated Procurement-Small Value Procurement (NP-SVP) as supplemented in the CY 2022 Annual Procurement Plan of the Region and pursuant to Annex H of the 2016 Implementing Rules and Regulations (IRR) of the Republic Act (RA) 9184 or the Government Procurement Reform Act , in NP-SVP , "The BAC shall prepare and send the RFQs to at least three (3) suppliers , contractors or consultants of known qualifications . This, notwithstanding, those who responded through any of the required postings shall allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof;

WHEREAS, the BAC awarded the said procurement activity last April 7, 2022 to Adamantem Consulting Services as the Single Rated and Responsive Bid;

WHEREAS, a copy of approved Purchase Order and Notice of Award was issued to the winning service provider last June 7, 2022;

WHEREAS, on June 14, 2022, a letter of withdrawal for the project was received by the BAC Secretariat from the said service provider (Please see attached);

WHEREAS, a BAC Resolution was issued for the cancellation of award and reposting of procurement activity last June 15, 2022;

WHEREAS, the BAC Secretariat posted the Request for Proposal in the PHILGEPS website and agency website for six (6)calendar days starting June 15 to June 21, 2022;
