WHEREAS, on October 10, 2022, the Bids and Awards Committee thru its Secretariat received an approved Purchase Request for the Lease of Venue of the Regional Social Pension Program Management Office Year-End Performances Review cum Capability Building in CALABARZON;

WHEREAS, the approved Budget for the Contract of the Lease of Venue is Two Hundred Thousand Pesos Only (Php 200,000.00);

WHEREAS, the above mentioned request has been supplemented in the Annual Procurement Plan for FY 2022 as per attached Supplemental Project Procurement Management Plan;

WHEREAS, within the set deadline, four (4) quotations were received by the BAC Secretariat. The quotations received are hereto attached, marked as Annex B and made an integral part hereof;

WHEREAS, a Table of Rating Factor was used as basis for criteria in selecting the right lease of yenue;
