WHEREAS, on November 16, 2022, the Bids and Awards Committee thru its Secretariat received an approved Purchase Request for the Catering Service of the Capability Building for Zero Hunger Program in Oriental Mindoro;

WHEREAS, the approved Budget for the Contract for the Catering Service is Sixty Thousand Pesos Only (Php 60,000.00);

WHEREAS, the above mentioned request has been supplemented in the Annual Procurement Plan for FY 2022 as per attached Supplemental Project Procurement Management Plan;

WHEREAS, following the procurement modality, Negotiated Procurement-Small Value Procurement (NP-SVP) as supplemented in the CY 2022 Annual Procurement Plan of the Region and pursuant to Annex H of 2016 Implementing Rules and Regulations (IRR) of the Republic Act (RA) 9184 or the Government Procurement Reform Act, in NP-SVP, "The BAC shall prepare and send the RFQs to at least three (3) suppliers, contractors or consultants of known qualifications.
