Expired Mayor's Permit</p>	<ul style="list-style-type: none"> <li>The BAC will accept the proof of application for the Mayor's Permit given that not all suppliers have already renewed their permits as part of the eligibility documents during the bid opening. As stated under Section 23.3 of RA 9184 "in lieu of Class A eligibility documents which includes the Mayor's Permit, the Bidder shall only submit a valid and updated PhilGEPS Certificate of Registration in accordance with Section 8.5.2 of the IRR of RA 9184 for purposes of determining eligibility hence not imposing the submission of renewed Mayor's Permit during the eligibility checking. Restricting the prospective bidders to comply with the updated Mayor's Permit will defeat the principle of competitiveness in public bidding. This document shall form part of the post-qualification documents to be required for the lowest calculated bidder.</li> </ul>

Machine testing fee shouldered by the bidder or by the Procuring Entity</p>	<p>3.a Under Section 18 of RA 9184, reference to brand names shall not be allowed except for the items or parts that are compatible with existing fleet or equipment of the same make and brand hence we cannot state the brand of rice.</p> <p>Technical Specifications of the Rice :</p> <p>Rice Must be white in color, medium grain, and regular to well-milled with approximately 75% whole grain and 25% broken rice.</p> <p>Shall be free from objectionable and foreign odor, live insects, pests, and other contaminants</p> <p><b>A sample of rice must be presented during the post-qualification process.</b></p> <p>3.b Regular Slotted shall be tested on sampling procedure which must be at least 10% of the total number of items.</p> <p>We do not have a preferred testing laboratory for the carton, however, during post-qualification, the TWG will check the samples of the carton to be used by the lowest calculated bidder. Machine testing fee if there is any should be shouldered by the bidder.</p>
