The Inspection and Acceptance Report prepared by the inspector and technical staff in the area together with Delivery Receipts and Sales Invoice are the documentary requirements to process the payment.

Checklist of Technical and Financial Documents.</p> <ul style="list-style-type: none"> Filling up the prescribed forms whether to indicate the 12% VAT or Non VAT.. 	<ul style="list-style-type: none"> The supplier's tax to be indicated in the bid form will depend on their BIR Registration. The BAC will evaluate the bid submitted by cooperatives and other non-cooperatives based on GPPB Circular 02-2010. As stated in item 3.3 of the said circular, "To ensure that all bids shall be evaluated on equal footing, all taxes itemized by non-cooperatives in their bids and which cooperatives are exempt shall be added to the bids of cooperatives strictly for purposes of evaluation and comparison".

Documentary Requirements needed during the Post Qualification if awarded for tax-exempt cooperatives</p>	<ul style="list-style-type: none"> One of the requirements that may be required will be a Certificate of Tax Exemption. Other post-qualification documentary requirements to be required will depend on the review of submitted eligibility documents.
