**Contract Agreement for Supply and Delivery of Various Food Items for the implementation of the 14<sup>th</sup> Cycle Supplementary Feeding Program in Occidental Mindoro for Lots 2 and 3**

**CONTRACT AGREEMENT**

THIS AGREEMENT was made this \_\_\_ day of 05 SEP 2024 2024 between:

The Department of Social Welfare and Development MIMAROPA Region located at 1680 F. T Benitez cor Malvar Sts., Malate, Manila, Philippines represented by **Regional Director LEONARDO C. REYNOSO, CESO III** (hereinafter called the "Procuring Entity") of the one part.

and

**GEMINI TWIN GOLD MARKETING**, a single proprietorship existing under and by virtue of the laws of the Philippines represented by its owner **MARYNOR D. JUANO** located at Jimenez St. Brgy. Poblacion, Calintaan, Occidental Mindoro (hereinafter called "the Supplier") of the other part;

**WHEREAS**, the Procuring Entity invited Bids through Competitive Bidding for certain goods and ancillary services, particularly the **"Supply and Delivery of Various Food Items for the implementation of the 14th Cycle Supplementary Feeding Program in Occidental Mindoro under Project ID No. DSWD4B-2024-023"**, and has accepted a Bid by the supplier for the supply of those goods in the sum of **Eight Hundred Ninety-Nine Thousand Forty-Eight Pesos and 75/100 Only (Php 899,048.75)** for Lots 2 and 3 inclusive of all applicable taxes ( hereinafter called "the Contract Price").

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as an integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletin, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to a request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of Eight Hundred Ninety-Nine Thousand Forty-Eight Pesos and 75/100 Only (Php 899,048.75) for Lots 2 and 3 or such other sums as may be ascertained, the Supplier agrees to *provide the goods and services and to remedy defects therein in conformity, in all respects,* in accordance with its Bid.
4. The *Procuring Entity* hereby covenants to pay the Supplier the Contract Price, subject to the Supplier's delivery of goods and services and remedying of defects.
5. When the supplier fails to deliver goods under the contract within the specified delivery schedule, the supplier shall pay the entity liquidated damages in an amount equal to one-tenth of one percent (0.001) of the cost of the unperformed portion for every day of delay. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the Procuring Entity may rescind or terminate the contract without prejudice to other courses of action and remedies available under the circumstances.
