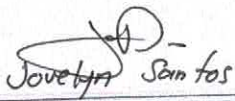

1. I am the sole proprietor or authorized representative of **AQUALIFE WATER STATION** with office address at Bansud, Oriental Mindoro];
2. As the owner and sole proprietor, or authorized representative of **AQUALIFE WATER STATION** I have full power and authority to do, execute and perform any and all acts necessary to participate, submit the bid, and to sign and execute the ensuing contract for Purchase of Drinking Water for the MIMAROPA YOUTH CENTER (Residents) for CY 2025 of the Department of Social Welfare and Development (MIMAROPA), as shown in the attached duly notarized Special Power of Attorney;
3. **AQUALIFE WATER STATION** is not "blacklisted" or barred from bidding by the Government of the Philippines or any of its agencies, offices, corporations, or Local Government Units, foreign government/foreign or international financing institution whose blacklisting rules have been recognized by the Government Procurement Policy Board, by itself or by relation, membership, association, affiliation, or controlling interest with another blacklisted person or entity as defined and provided for in the Uniform Guidelines on Blacklisting;
